Subject: - Compassionate appointment of Sh.Vipul S/o Sh. Harish Kumar R/o H.No. 90 - Shastri Nagar, Tehsil & District Jammu, under SRO-43/1994.

In terms of the J & K Compassionate appointment Rules, 1994, notified vide SRO 43 dated 22-02-1994, sanction is hereby accorded to the temporary appointment of Sh. Vipul S/o Sh. Harish Kumar R/o H.No. 90 - Shastri Nagar, Tehsil & District Jammu as Orderly in the Pay Band of 4440-7440 with Grade Pay of Rs. 1300/= in the Labour Department under SRO-43 of 1994.

The appointee shall report in the office of Labour Commissioner, J&K Jammu within a period of 21 days from the date of issuance of this order and shall be allowed to join only after the production of following documents/ certificates in original as required under rules:-

1. Academic Qualification Certificate.
2. Date of Birth Certificate.
3. Permanent Resident Certificate.
4. Health Certificate issued by the Chief Medical Officer, (Physical fitness certificate).
5. No loan certificate under self Employment Scheme from DIC concerned and Employment Department.
6. Category Certificate, if any.

The appointee shall be initially on probation for a period of two (2) years. If on verification, the certificate produced by the appointee are proved to be fake or forged, the appointment shall stand cancelled abinitio.

The appointee shall give an undertaking in the shape of an affidavit duly attested by Ist Class Judicial Magistrate to the effect that in case any adverse report about his Character and Antecedents is received from Inspector General of Police, (CID), J&K to whom a reference shall be made by the Department, the appointee shall have no right to claim

his appointment as Orderly and his appointment as such shall be deemed to have been cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of his character and antecedents and other certificates is received.

The appointment of the above candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24th December 2009.


