Whereas, the Department Promotion Committee meeting was held on 02.08.2018 in which among other officials Smt Ranjana Kohli, Junior Assistant was also cleared and promoted as Senior Assistant vide Order No. 173-LC of 2018 dated 28.08.2018.

Whereas, Smt. Ranjana Kohli, was adjusted in the office of Insurance Medical Officer, ESI, Dispensary Bari-Brahmana vide this office order No. 226-LC of 2018 dated 17.12.2018 as Senior Assistant against Shri Bodh Raj, Senior Assistant.

Whereas, Smt. Rajana Kohli, Senior Assistant submitted an application alongwith duly sworn on affidavit to this office for foregoing her promotion as Senior Assistant owing to health reason and not claiming for further promotion in future.

Whereas, as per O.M No. A/31(97)-488 dated 07.01.2019, issued by Finance Department which reveals that in case an employee after availing in-situ promotion on a particular post, foregoes functional promotion granted subsequently, the employee shall be reverted to his/her original lower pay scale he/she was holding prior to such in-situ promotion under these rules.

Now, in view of the above, Smt. Ranjana Kohli, Senior Assistant in the office Insurance Medical Officer, ESI dispensary Bari-Brahmana is reverted back to the post of Junior Assistant and is adjusted in the office of Assistant Labour Commissioner, Jammu against available vacant post of Jr. Assistant.

Assistant Labour Commissioner, (Drawing and Disbursing Officer) Jammu is also asked to refix the pay of the said official after obtaining Last Pay Certificate/Service Book and in accordance with rules of High Standard Pay Scale Scheme (In-situ promotion thereof).
