In the interest of administration and due to ongoing pandemic of Covid-19 and in partial modification to this office order No's :-92-LC of 2020 dated 21.07.2020, 95-LC of 2020 dated 21.07.2020, following transfers and postings are hereby ordered with immediate effect:-

01. Sh. Manzoor Ahmad (ALWO) in the office of Assistant Labour Commissioner Chandigarh is transferred and posted in the office of Assistant Labour Commissioner Anantnag. His salary shall be drawn against the available post of Caretaker.
