As recommended by the Secretary J&K Service Selection Board vide No. SSB/Secy/Sel/03(M)/2020/1021-27 dated: 27-01-2020 and its approval conveyed by Labour & Employment Department, Civil Secretariat, Srinagar vide letter No. L&E/Lab/99/2017 dated 24-02-2021, sanction is hereby accorded to the temporary appointment of following candidate as Labour Inspector carrying the pay level-6 (35400-112400) under Hon'ble Prime Minister's Special Package with immediate effect.

Sanction is also accorded to the transfer of (01) supernumerary post of Labour Inspector out of total sanction of Seven (07) posts created in the Labour & Employment Department vide Govt. Order No.58-DMRR&R of 2017 dated 29.07.2017 by the Department of Disaster Management Relief, Rehabilitation & Reconstruction (DMRR&R) to the office of Assistant Labour Commissioner, Kupwara.

Consequent upon above appointment Smt. Tanveera Bashir, is hereby posted as Labour Inspector, Circle-I Kupwara with additional charge of Circle-II Kupwara. His appointment and subsequent adjustment however, is subject to the following terms and conditions: -



- i) She shall be initially on probation for a period of two years.
- ii) She shall report at her place of posting within a period of (21) days from the date of issuance of this order.
- iii) She shall furnish following certificates in original to the concerned DDO at the time of her joining:-
- (1) Permanent Resident Certificate.
 - (2) Date of Birth Certificate
 - (3) Health Certificate issued by CMO of the District.
 - (4) Academic and Technical Qualification certificates.
 - (5) Certificate from the District Industries Centre (DIC) and District Employment and Counseling Centre to the effect that no loan under any Self Employment scheme has been availed by the appointee.
 - (6) Relevant Category Certificate, if any.
 - (7) Migrant status including migration certificate and any other relevant certificate issued by the competent authority at the time of joining.
- iv) If she fails to join within a period of 21 (twenty one) days from the date of issuance of this order, she shall forego her right to appointment which shall be deemed to have been cancelled abinitio without any further notice.
- v) If she is not already in service, she shall give an undertaking in the shape of an affidavit to the effect that:-
- a) In case of adverse report about his/her character and antecedents is received from the Additional Director General of Police, Criminal Investigation Department to whom a reference shall be made by the Department of Labour, she shall have no claim for the appointment as Labour Inspector and her appointment as such shall be deemed to have been cancelled abinitio.
 - b) If on verification of the qualification certificate/reserved category certificate /experience/ migrant certificate (whichever is applicable) is found forged, false or fake, the appointee shall have no claim for her appointment which shall be deemed to have been cancelled abinitio.
- vi) Her salary shall not be drawn and disbursed unless the satisfactory report/genuineness of the certificate in respect of (v) (a) and (b)



- * above is received and funds under Hon'ble PM's Special Package are released by the Administrative Department.
- vii) She shall execute an agreement in the Form prescribed under Jammu and Kashmir, Kashmiri Migrants (Special Drive) Recruitment Rules, 2009 issued vide SRO-412 of 2009 dated 20-12-2009 that she will serve in the Valley against the post on which she has been appointed and at a place where she will be posted. In case the appointee migrates from valley after appointment/posting for any reason whatsoever, she shall loose the job without any notice and her service shall stand terminated without any notice.
- viii) Her inter-se-seniority shall be determined as per the merit obtained in the selection list of J&K SSB.
- ix) This appointment/ adjustment shall be subject to outcome of the writ petition, if any pending before the competent court of law.
