Subject:- Issuance / Renewal of licenses under Shops & Establishment Act by the Labour Department.

Order No: 92- LC of 2018

Whereas, instances have come to the notice wherein licenses issued under shops & Establishment Act on verification have been found to be fake;

Whereas, it has also been observed that the department does not prepare & retain in record copy of the license so issued which creates problems in the process of the verification at times;

Whereas, it has also been observed that the designated issuing authority does not mention his/her name and designation while issuing/renewing such licenses;

Whereas, the matter was taken up with the administrative Department who has conveyed approval to the issuances of licenses in the following manner henceforth:

1. The Registration certificate being printed through Government Presses shall be henceforth got printed on a thick paper having the logo of State Emblem and the words "**J&K State Labour Department**" either Embossed or with water marking with a hologram incorporated on it.
2. Duplicate copy of the Registration certificate bearing the same serial number, shall be retained in the office records to check the authenticity of the registration certificate issued, if need arises.
3. In addition to the format already prescribed under the J&K Shops & Establishment Act, 1966 & Rules made there under, the following disclaimers shall be put in the certificate:-

***"The registration certificate is issued for the purpose of regulating Shops & Establishments under J&K shops & Establishment Act,***

**1966 and in no case it shall be construed as a document valid for any other purpose like:-**

- i) Deciding title over the Shops/Establishment.**
- ii) Getting loan from any banking or other financial institutions. "**

Further, it is directed that only the officer designated to be incharge of the specific area alone shall issue /renew the licenses and only in situations where the designated officer proceeds on sanctioned earned leave, the licenses shall be issued/renewed by the officer to whom the charge of the area is assigned by the competent authority by an order. Besides each designated officer shall affix stamp bearing his name and designation below his signatures.

This Order will have immediate effect.
