Sanction is hereby accorded to the temporary appointment of Mr. Tawseef Yasin Sheikh S/o Mohd Yasin Sheikh R/o Yamrach, Tehsil Yaripora, District Kulgam as Care-Taker under OM category in the Pay Level-4 (25500-81100) in the J&K Labour (Subordinate) Service with immediate effect.

The appointee shall report to the Labour Commissioner, J&K within a period of 21 days from the date of issuance of this order and in case he fails to join within the stipulated time, he shall forego his right to appointment, which shall be deemed to have been cancelled ab-initio without any further Notice.

The appointee shall be allowed to join only on production of following certificates/documents (in original) to be verified subsequently:

1. Academic / Technical Qualification Certificates.
2. Matriculation/ Date of Birth Certificate.
3. Health Certificate from the concerned Chief Medical Officer of the District.
4. Domicile Certificate issued by the Competent Authority.
5. Certificate from District Industries Center (DIC) and District Employment & Counseling Center to the effect that no Loan under Self Employment Scheme has been availed by the appointee.

The appointment of the appointee shall further be subject to the following conditions:-

- (a) The appointee shall give an undertaking in the shape of Affidavit to the effect that if, on verification, genuineness of his qualification and Date of Birth Certificates from the concerned issuing authorities are found fake / forged, the claim of the appointee for appointment as Care-Taker in the J&K Labour (Subordinate) Service shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- (b) The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of genuineness of Qualification/ Date of Birth are received from the concerned authorities/ agency.
- (c) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated: 24-12-2009.
- (d) The inter-se-seniority of the appointee in the J&K Labour (Subordinate) Service shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- (e) The appointment shall be subject to outcome of writ petition(s), if any, pending before Competent Court of law.
